DLC provided 34,000 noon meals, 64,000 snacks, 92,000 nursing contacts, 26,000 transportation contacts and over a million activity contacts. 75% of clients reported satisfaction with the program. 25% did not respond to satisfaction survey. There were zero with negative responses.

Over the last five years the DLC has provided over \$1,146,000 worth of free services to individuals needing the services that the DLC provides. DLC has recently been recognized as an innovative champion and a board member was awarded a national prize for working with others in the community to improve the lives of low income individuals. In
